

CoSolvent Player License Agreement

CoSolvent Player is solely owned by Interactive Point of View, Inc. Interactive Point of View, Inc. (iPOV.net) grants you a nonexclusive limited license to use the CoSolvent Player in accordance with these Terms and Conditions (the "license") issued by our company. By using the CoSolvent Player, you acknowledge that you have read and agreed to this license agreement.

1. You may use the product on **commercial websites** by purchasing a Professional user license. A commercial website means:
 1. any site which is built, owned or maintained by a profit-making person or organization, even if the site does not generate revenue;
 2. any site which generates revenue, even if it's otherwise non-commercial;
 3. government, government-agency or political-party websites.
2. A Professional license is required for:
 1. Use by single 'solo' web master, covering all sites and/or domains that said web master personally maintains.
 2. Use by a corporation, covering a single internet or intranet hostname (sometimes referred to as a site or domain name) on which the CoSolvent Player may be deployed.
 3. Use in an embedded mode, covering shipping the CoSolvent Player embedded as part of a larger product: either a packaged web site (whether sold to a 3rd party for deployment or shipped on a CD, Flash Disk, or other medium) or a larger Flex application. An individual license is required for each such use and covers any number of copies made, including any subsequent versions or releases of the embedding system.
3. You may use the Personal license on **personal websites** free of charge subject to the terms of this license. A personal website means: personal or hobby sites which generate no revenue (whether from advertising, commissions, sales or any other source).
4. You may use the Personal license for up to 30 days for the sole purpose of evaluating the CoSolvent Player before purchase of a professional license. During the evaluation period you must take reasonable steps to ensure that the CoSolvent Player is only accessible to members of the development team and direct customers, e.g. you may not deploy the CoSolvent Player to a 'beta' site which can be accessed by the general public.
5. You can not agree to these terms on behalf of a third-party - if your own interest in the site is in any way commercial (for example, a freelancer being paid to build it) then a commercial license is always required, even if the site is for a non-commercial organization.
6. Except as covered by embedded use, you may not sell or redistribute any of our products in any form or in any medium, whether original or modified or for profit or not.
7. You agree not to alter or remove any of the source code without explicit written permission from CoSolvent.biz / iPOV.net.
8. You agree not to use the product on illegal sites, or on pages which contain illegal material.
9. The terms of this agreement shall be governed by American law, therefore you may not use the product at all in jurisdictions where this agreement is itself illegal, or where you are not empowered to enter into such an agreement.
10. **No Warranty:** Except as expressly set forth in this License, the Licensed Programs are provided on an "as is" basis, without warranties or conditions of any kind, either express or implied including, without limitation, any warranties or conditions of title, non-infringement, merchantability or fitness for a particular purpose. Each Licensee is solely responsible for determining the appropriateness of using and distributing the Licensed Programs and assumes

all risks associated with its exercise of rights under this agreement, including but not limited to the risks and costs of program errors, compliance with applicable laws, damage to or loss of data, programs or equipment, suitability for hosting and unavailability or interruption of operations.

11. **Limitation of Liability:** Except to the extent required by applicable law, in no event will Licensor be liable on any legal theory for any special, incidental, consequential, punitive or exemplary damages arising out of this License or the use of the Licensed Programs, even if Licensor has been advised of the possibility of such damages.
12. **Indemnity:** Licensee shall indemnify Licensor, its employees, officers, licensee and agents for all damages, costs and expenses, including, without limitation, attorneys' fees, arising from any claims arising as a result of Licensee's use of the Licensed Programs as provided hereunder.
